## Presenters

### Dr. James Connor (University of New South Wales)

James is a sociologist at the UNSW@ADFA specializing in emotions and sport. He is particularly interested in the concept of the 'networked athlete' and how the increasing regulation, control and monitoring of the athlete's body impacts their sense of self. A further research area in sport is the value for money and perceived benefits that elite sport provides. He has published in a range of leading journals, including British Journal of Sport Medicine, Sport in Society, and many others.

### Dr. Terry Engelberg (Griffith University/ University of Canberra)

Terry is a Research Fellow in the Griffith Business School currently working on various Australian Anti-Doping Research Program (ADRP) and The World Anti-Doping Agency (WADA) funded projects on anti-doping. She is also a part-time senior lecturer in Sport Psychology at the University of Canberra. She is a certified athletics coach and a former Board member of the Sport Management Association of Australia and New Zealand. In 2006 she received an Australian Sports Commission Sport Leadership Grant for Women. Her current research interests are crime and corruption in sport, morality in sport, and community sport management.

### Professor Allan Hahn (University of Canberra)

Allan recently stepped down as the Chief Scientist of the Australian Institute of Sport, where he was employed for 27 years. He now holds several part-time positions including Professorial Research Fellow at the University of Canberra, Research Leader for Coaching at the Queensland Academy of Sport, and Professor in Sport Partnerships at Victoria University. He contributed substantially to research that led to the introduction of a test for the banned drug erythropoietin at the 2000 Sydney Olympic Games. He has received an Order of Australia Medal from the Australian Government in recognition of his services to sport and sports science. He is currently interested in assessing the effectiveness of PCYC programs as crime prevention programs.

### Dr Kathryn (Kate) Henne (Australian National University)

Kate joined the Regulatory Institutions Network (RegNet) at the Australian National University as a Research Fellow in July 2011 after completing her PhD in Criminology, Law and Society at the University of California. She has conducted research on international, Australasian, and North American sport regulations courtesy of funding from the U.S. National Science Foundation and the International Olympic Committee.

### Associate Professor Lynne Magor-Blatch (University of Canberra)

Lynne has more than 35 years' experience in the alcohol and other drug (AOD) field, and has worked within the non-government and Government sectors as program director, policy officer and consultant, and within Mental Health as Secretariat Manager to the National Mental Health Working Group and the National Comorbidity Taskforce; in crisis counselling and intervention; child and adolescent mental health; and forensic services. In 2010, Lynne was inducted into the National Alcohol and Drug Honour Roll for significant contributions to the AOD sector.

### Dr. Jason Mazanov (University of New South Wales)

Jason is a Senior Lecturer at UNSW@ADFA. His main research interest is looking at the causes and consequences of drug use in sport. He edited a special issue of *Sport in Society* that defined an agenda to guide social science inquiry into drugs in sport phenomena. He is also interested in the impact of corruption and scandal in sport. With James Connor, Jason recently edited a special issue of the *International Journal of Sport Marketing and Sponsorship* on the topic of Scandal and Corruption in Sports Marketing.

### Associate Professor Stephen Moston (University of Canberra)

Stephen is Head of Discipline of Psychology at The University of Canberra. He is an expert in the field of forensic interviewing and has published widely on police interrogation practices and suspect behaviour. He has conducted several research studies on sports doping issues for the ADRP, and another for WADA. His current research interests centre on the use of forensic interviewing techniques to detect athletes who are doping.

### Ms. Catherine Ordway

Catherine is an international expert in the field of sports law and anti-doping. On behalf of the Australian Olympic Committee, Catherine appeared in over thirty anti-doping hearings, before the Court of Arbitration for Sport or National Sports Dispute Centre, in the lead up to the Sydney Olympic Games. She has held a number of senior roles within the Australian Sports Anti-Doping Authority (ASADA), including Group Director, Detection, where she was responsible for ASADA's testing, intelligence and investigations functions.

### Mr. Tom Sloan (University of NSW /Australian National University)

Tom won a prestigious, competitive Summer Scholarship with UNSW in Canberra to work on scandal in Rugby League. He is completing his undergraduate degree at ANU.
